

This Personal Information Collection Statement and Agreement (hereinafter referred to as the “Agreement”) is made by Space Concepts Ltd., Co. (the “Space”) in accordance with the Article 8 of Personal Information Protection Act (the “Act”) shall clearly inform you following issues:

**1. Purposes of Collection**

Space collects your personal information to meet the needs of membership management, marketing and any rights and obligations based on contracts.

**2. Classification of Personal information:**

- (1) Type of identification (e.g. Name, I.D. Card number, Address, E-mail address, Photograph, The number and name for financial institution’s account, The number of credit card or VISA card and any other number or account of individual, etc.)
- (2) Type of characteristic (e.g. Age, Gender, Date of Birth, Height, and Weight, etc.);
- (3) Family;
- (4) Record of health and
- (5) Other information detailed in the relevant purposes of collection.

**3. Period, Areas, Parties and Way of the Use of Personal information:**

- (1) Period: Retention period in accordance with the relevant laws/regulations or in line with business needs or individual contracts.
- (2) Area: Location of Space and the institutions in relation to relevant business.
- (3) Parties: Space (including the affiliated company, associated company), Space’s jointly marking or customer information sharing companies, Space’s business cooperative units and legally investigation authority or competent authority.
- (4) Ways: By way of automatic or non-automatic measures that is compliance with personal information protection relevant regulations.

**4. According to Article 3 of the Act, you may exercise following right with regard to your personal information collected by Space:**

- (1) You may inquire and request for a review your personal information, but Space may charge a necessary handling fee.
- (2) You may request to make duplications of your personal information, but you shall explain the reason and fact properly.
- (3) You may request to supplement or correct your personal information.
- (4) You may request Space to discontinue collection, processing or using your personal information.
- (5) You may request Space to delete your personal information.
- (6) However, Space may reject your requests in order to the request does not consistent with the application procedures, rules or Space has an obligation to keep, or the law provides otherwise.

**5. The impact of nondisclosure of personal information:**

You are in the position to decide whether providing personal related information and classification. However, Space may not be able to provide you relevant services or better services or better services if Space may not process necessary checking in terms of the operation requirement due to the lack of your personal information and classification. Your understanding is appreciated.

6. You may lose certain rights or benefits if you provide incorrect, untrue, outdated or incomplete personal information.
7. If you want to change, inquire, supplement or correct or discontinue using your personal information, you may contact Space, or you may directly go to Space studio fill in the written application form. Space will continue to use the personal information provided by you for marketing and service before you request Space discontinue using your personal information
8. For matters not specified in the Agreement, Space will follow the Act or applicable laws and regulations.
9. The English translation is only for reference, in the event of any discrepancy between the Chinese and English texts hereof and thereof, the Chinese version shall govern.
